



1. Introduction

- 1.1 These terms and conditions shall govern your use of our website
- 1.2 By using becoming a member, you accept these terms and conditions in full; accordingly, if you disagree with these terms and conditions or any part of these terms and conditions, you must not sign up

2. Copyright Notice

3. License to Members Zone

- 3.1 You may:
 - a) view pages from the zone in a web browser;
 - b) download PDF pages from our zone for personal use;
 - c) print pages from our zone;
 - d) stream audio and visual files from our zone; and
 - e) use our Members Zone services by means of a web browser, subject to the provision of these terms and conditions

- 3.3 Unless you own or control the relevant rights in the material, you must not:

5. **Code of Conduct**

5.1 Being part of The Virtual Run Club you agree to reasonable behaviour towards our coaches and other members. Any behaviour deemed offensive, inappropriate or defamatory, or which puts other members at risk will compromise your position in the club

5.2 We reserve the right to cancel your membership at any time if you are disrespectful, disruptive or are found to have breached the Terms and Conditions

5.3 We also reserve the right to refuse membership of the club to any person for any reason at our absolute discretion

5.4 You are not able to use the club's network to sell or promote your own individual causes

5.5 We reserve the right to take posts from The Forum down in order to keep the content engaging and relevant to our members

5.6 This club has been created to connect runners and assist with training. We ask our members to be respectful to one another, and not to share anything outside of The Forum

6. **Age and Liability**

6.1 The minimum age to join is 18

- a) by signing up you agree that you are over the age of 18

6.2 By taking part in any sessions, warm-ups, conditioning, workouts or other activities on the site, you do so at your own risk and the club is not liable for any injury, loss, death or damage resulting from you taking part

6.3 It is your responsibility to make sure you are medically fit to train

6.4 You must acknowledge that taking part in any of the activities on the site can be hazardous and strenuous, and you should not take part unless capable of completing the activity

7. **Personal Data**

7.1 All personal data collected is used solely by J & G Run Club to administer your membership and provide membership services. The club does not supply any personal data it holds for this purpose to any other third party. These services include:

- a) anonymising your data to analyse and monitor club trends
- b) sending you a club survey to improve your experience as a club member. You will receive your survey upon signing up
- c) creating your profile on the Members Zone

7.2 The club has the following social media pages: Instagram. All members are free to join. If you join the social media page, please note that the provider of the social media platform(s) have their own privacy policies and that the club do not accept any responsibility or liability for these policies. Please check these policies before you submit any personal data on the club social media pages



- 7.3 We will hold your personal data on file for as long as you are a member with us. Any personal data we hold on you will be automatically deleted once you terminate your membership. Your data is not processed for any further purposes other than those detailed in this policy
- 7.4 As a data subject you are not obliged to share your personal data with the club. If you choose not to share your personal data with us we will be unable to administer your membership

8. Membership Types

- 8.1 J & G Run Club offer two types of membership packages: Monthly Membership and Annual Membership:
 - a) for these package types payment is collected on the 1st day of the membership period
 - b) these membership do not have a minimum contract terms
 - c) the memberships continue to roll on a monthly or annual basis. See 9. for how to cancel a membership
- 8.2 Membership will be taken automatically at the start of each Monthly or Annual term.
- 8.3 J & G Run Club reserve the right to change the membership fee at any point:
 - a) the change of fee will be applicable to new members only
 - b) existing members will be exempt from any membership fee changes unless otherwise notified
 - c) if you cancel your membership, then take out a new membership with the same details, you will be considered a new member
- 8.4 J & G Run Club membership fees are non-refundable:
 - d) when cancelling membership, it is down to the individual to ensure their membership has been cancelled
 - e) J & G Run Club will not issue refunds for membership fees unless a proof of cancellation can be provided

9. Cancel Your Membership

- 9.1 you reserve the right to opt out at any time
- 9.2 J & G Run Club do not require any advance written notice for membership cancellation
- 9.3 In accordance with 8.4, membership fees are non-refundable

10. Termination of Membership by J & G Run Club

- 10.1 J & G Run Club may terminate a Membership without notice and with immediate effect if:
 - a) the member breaches these terms;
 - b) J & G Run Club are of the opinion that the member is not suitable for continued membership; or
 - c) the member puts the safety or well-being of others at risk
- 10.2 All decisions made by J & G Run Club under this clause are final and binding
- 10.3 J & G Run Club are unlikely to accept a new application for membership from someone whose membership has been terminated in accordance with this clause
